What is CASA?

Court Appointed Special Advocates (CASA) for Children is a network of community-based programs that recruit, train and support citizen-volunteers to advocate for the best interests of abused and neglected children in courtrooms and communities.

CASA began in 1977, when a Seattle juvenile court judge, concerned about making drastic decisions with insufficient information, conceived the idea of citizen volunteers speaking up for the best interests of abused and neglected children in the courtroom.

Today CASA is a network of more than 950 programs in 49 states recruiting, training, and supporting volunteers to represent the best interests of abused and neglected children in the courtroom and other settings.

Volunteer advocates — empowered directly by the courts — offer judges the critical information they need to ensure that each child's rights and needs are being attended to while in foster care.



The Office of the Inspector General (OIG) reports that children with a CASA advocate are "substantially less likely to spend time long-term foster care." Families with a CASA volunteer receive more services, leading the OIG to conclude that, "CASA is effective in identifying the needs of children and parents." Cases where CASA is involved are more likely to be "permanently closed."





Every 35 seconds a child is abused or neglected.² Many of these children end up in foster care.



12% of children in foster care end up homeless³

50% of children in foster care do not graduate high school or get a GED³





40% of abused and neglected children are served by CASA SHaW⁴



96.5% of children served by CASA SHaW do not return to foster care.
